The records in this series document the planning process for these events, including the selection of guest speakers, the organization of the dinner and rental of the event locale, and the confirmation of member attendance and event fee payments. These records include programs and notices, invitations, guest lists, speaking notes, invoices, correspondence, financial statements, notes, timetables and seating plans.
